- c) Landscaping of common area next to 1190 Glass Lake Circle Rosa confirmed that the company has seeded grass and still has plans to plant wildflowers
- d) 1270 & 1420 Glass Lake Circle response to letters to board regarding boats Brian J will draft response letters allowing those two boats to be grandfathered as long as they do not use common areas to remove them no action since last meeting
- e) Management of Boats on Glass Lake & use of Birdie Beach to launch signage Brian J is still working with NOPM on specific design and cost estimate
- f) 1270 GLC proposal to address erosion at retention pond Beau to follow-up with homeowner
- g) Birdie Beach Improvement project status Brian sent pictures of the erosion concern to Jeremy. Jeremy believes the issue may improve as new grass roots in.
- h) Common area tree trimming Brian discussed that he is not comfortable using "A Cut Above" for trimming of all common area trees due to lack of responsiveness. Will rebid to additional companies in the spring.
- i) Snow removal bids Bids were reviewed and the board approved a new contract with Hardscapes for the 2021-2022 season.
- j) Management Company bids We have already received two bids and will request a third bid from NOPM. Board will review and decide a company at the next meeting.
- k) Street trees Doug to verify houses that did not install trees per requested deadline.
